Determination Number 5 of 1998

REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from date of determination or as otherwise indicated:

PART 1

FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part, Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Table 1 of Part 1 of the Principal Determination is further amended by:
 - (a) amending the rate per annum of salary for the Chief Government Information Officer to \$117,201, effective from date of occupancy
 - (b) increasing the rate per annum of salary for the Commonwealth Deputy Ombudsman to \$108,148, and
 - (c) against the office of Executive Director, Special Broadcasting Service, inserting the following footnote:

“Loading of 15% additional to basic rate per annum of salary, whilst occupied by Mr Nigel Milan, effective from date of appointment.”
3. Under clause 4.1 of Part 4 of the Principal Determination an amount of \$12,000 is payable to Mr M F Lynch, General Manager of the Australia Council, for the 12 month assessment period, 1996/97.

PART 2

PART-TIME HOLDERS OF PUBLIC OFFICE

4. In this Part, Determination No 16 of 1997 is referred to as the Principal Determination.
5. Table 1 of Part 1 of the Principal Determination is amended by:
- (a) increasing the rate per annum of fees for the Chair and Deputy Chair of the Aboriginal and Torres Strait Islander Development Corporation to \$35,700 and \$23,900 respectively, and
 - (b) inserting the following:




