Determination Number 15 of 1998

REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from the date of determination or as otherwise indicated:

PART 1

FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part, Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Table 1 of Part 1 is further amended by:
 - (a) amending Director, Office of Asset Sales to read Director, Office of Asset Sales and Information Technology Outsourcing
 - (b) amending Chief Executive, National Capital Planning Authority to read Chief Executive, National Capital Authority
 - (c) against the office of Chief Executive, National Capital Authority, inserting the following footnote:

“In addition to basic salary a loading of \$20,000 per annum to be paid to Ms A Pegrum from date of her appointment”
 - (d) amending the rate per annum of salary for the Chief Executive Officer, ESRA to \$72,000, effective from 1.5.98.
3. Table 4.3 of Part 4 is further amended by amending Chief Executive, National Capital Planning Authority to read Chief Executive, National Capital Authority.

PART 2

PART-TIME HOLDERS OF PUBLIC OFFICE

4. In this Part, Determination No 16 of 1997, as amended, is referred to as the Principal Determination.

5. Table 1 of Part 1 is further amended by:

(a) inserting the following:

(b) inserting the following footnote against Sydney Airports Corporation Limited:


“ An additional fee of \$3,500 per annum is payable to Board Members for a period of six months from date of appointment; an additional fee of \$3,500 per annum is payable to Board Members for the twelve month period from 1 September 1999 to 31 August 2000; Board Members who are members of the Audit Committee will receive an additional \$3,500 per annum.”

6. Table 2 of Part 2 of the Principal Determination is further amended by inserting the following:


