

# REMUNERATION TRIBUNAL

## Determination Number 22 of 1998

### REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from the date of determination or as otherwise indicated:

#### PART 1

##### FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part, Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Table 1 of Part 1 of the Principal Determination is further amended by amending the rate per annum of salary for the Chief Executive Officer, Family Court of Australia to \$123,679.
3. Under clause 4.1 of Part 4 of the Principal Determination an amount of:
  - (a) \$15,000 is payable to Mr Russell Reichelt, Director, Australian Institute of Marine Science, for the 12 month assessment period, 1997/98, and
  - (b) \$12,000 is payable to Mr Louis Milkovits, Managing Director of the Defence Housing Authority, for the 12 month assessment period, 1997/98.

#### PART 2

##### COMMONWEALTH SCIENTIFIC AND INDUSTRIAL RESEARCH ORGANIZATION

4. In this Part, Determination No 27 of 1995, as amended, is referred to as the Principal Determination.
5. Under clause 2 of the Principal Determination an amount of \$41,530 is payable to Dr McIntosh, Chief Executive Officer of the Commonwealth Scientific and Industrial Research Organization, for the 12 month assessment period, 1997/98.

PART 3

PART-TIME HOLDERS OF PUBLIC OFFICE

6. In this Part, Determination No 16 of 1997, as amended, is referred to as the Principal Determination.
7. The Principal Determination is further amended by:
- (a) into Table 1 of Part 1
- (i) inserting the following:

- (ii) inserting against the office of Member, Commonwealth Services Delivery Agency the following footnote:

*“Commonwealth Services Delivery Agency Members who are members of the Audit Committee will receive an additional fee of \$3,500 per annum. For a period of one year from 15 January 1998, Commonwealth Services Delivery Agency Members who are members of the Information Technology Committee or the Quality Performance Committee will receive an additional fee of \$3,500 per annum for each Committee membership.”*

- (iii) inserting against the office of Member, Private Health Insurance Administration Council the following footnote, effective from 1 July 1998:

*“Private Health Insurance Administration Council Members who are members of the Audit Committee will receive an additional fee of \$3,500 per annum.”*


