Determination Number 24 of 1998

REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from the date of determination or as otherwise indicated.

PART 1

FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part, Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Under clause 4.1 of Part 4 of the Principal Determination amounts of \$20,000 and \$16,000 respectively are payable to the Managing Director and Deputy Managing Director of the Australian Trade Commission (AUSTRADE), for the 12 month assessment period, 1997/98.

PART 2

PART-TIME HOLDERS OF PUBLIC OFFICE

3. In this Part, Determination No 16 of 1997, as amended, is referred to as the Principal Determination.
4. Table 1 of Part 1 of the Principal Determination is further amended by:
 - a) amending the rate per annum of fee for Member, Private Health Insurance Administration Council to \$27,500 from the date of appointment;
 - b) amending the footnote relating to the Chairperson of the Australia Council to read:

“In addition to basic fee a special allowance of \$25,500 per annum to be paid to Dr M Seares from date of her appointment and an additional allowance of \$39,300 while she acts in the position of Executive Chair.”

- c) inserting the following with effect from the date of appointment:

- e) Replacing the reference to Professional Committees – Health and Family Services Portfolio with Professional Committees – Health and Aged Care Portfolio.

PART 3

DIRECTOR, CIVIL AVIATION SAFETY AUTHORITY

6. In this Part, Determination No 14 of 1998, as amended, is referred to as the Principal Determination.

7. The Principal Determination is further amended by:

a) amending paragraph 2(i) to read:

“The level of performance based remuneration payable shall be an amount determined by the Remuneration Tribunal having regard to an assessment by the Board of the Civil Aviation Safety Authority from time to time.”

PART 4

NATIONAL NATIVE TITLE TRIBUNAL

8. In this Part, Determination No 2 of 1994, as amended, is referred to as the Principal Determination.

9. Part 1 of the Principal Determination is further amended by:


a) inserting the following with effect from date of appointment:

President (non-judicial), National Native Title Tribunal	87% of salary payable from time to time to President (judicial)	Capital City – 320 Other than a Capital City – 165


