Determination Number 27 of 1998

REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from the date of determination or as otherwise indicated.

PART 1

FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Table 1 of Part 1 of the Principal Determination is further amended by inserting against the office of Chief Executive Officer, National Occupational Health and Safety Commission the following footnote:

“Remuneration of 119,545 per annum and the office-holder supplement specified in Part 5 as pertaining to that level shall be payable to Mr Alan Rowe from date of his appointment.”

3. Table 6.1 of Part 6 of the Principal Determination is further amended by:
 - (a) amending the rate per annum of salary for the offices of Clerk of the Senate and Clerk of the House of Representatives to \$130,000 and the offices of Secretary to the Joint House Department and the Principal Parliamentary Reporter to \$105,000, with effect from 1 December 1998.
 - (b) deleting the office of Parliamentary Librarian.

PART 2

PART-TIME HOLDERS OF PUBLIC OFFICE

4. In this Part Determination No 16 of 1997, as amended, is referred to as the Principal Determination.
5. Table 1 of Part 1 of the Principal Determination is further amended by:

(a) inserting the following:

(b) adding the following footnote to the office of Member, Australian Prudential Regulation Authority, effective from date of appointment:

“Members who are members of the Risk Management and Audit Committee will receive an additional \$5,000 per annum.”

6. Table 3 of Part 3 of the Principal Determination is further amended by:

- (a) amending the rate per annum of fee for the offices of Deputy Chair and Member of the Australian Wheat Board Ltd to \$56,000 and \$40,000 respectively
- (b) deleting from the footnote to the Australian Wheat Board Ltd the following:

“and those Members who are members of the Audit Committee will receive an additional \$3,500 per annum.”


(c) inserting the following:


