Determination Number 1 of 1999

REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to sub-sections 8(2) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration to be paid to holders of public offices, and other matters significantly related thereto, and determines as hereunder, with effect from the date of determination or as otherwise indicated.

PART 1

FULL-TIME HOLDERS OF PUBLIC OFFICE

1. In this Part Determination No 19 of 1994, as amended, is referred to as the Principal Determination.
2. Table 1 of Part 1 of the Principal Determination is further amended by:
 - (a) Amending the rate per annum for the office of Managing Director, Australian Tourist Commission to \$130,000.
 - (b) Amending the rate per annum for the office of Chief Executive Officer, Family Court of Australia to \$130,000 with effect from 15 December 1998 and adding the following footnote:

“An Office-Holder Supplement of \$11,500 per annum shall apply, effective from 15 December 1998, rather than the rates specified in Part 5 of this Determination.”

- (c) Amending the footnote for the offices of Senior Member, Social Security Appeals Tribunal and Member, Social Security Appeals Tribunal as follows:

“Salary and the office-holder supplement specified in Part 5 shall be payable on a pro rata basis in accord with the proportion of full-time hours worked subject to the employment being at least half of the full-time rate.”

PART 2

COMMONWEALTH SCIENTIFIC AND INDUSTRIAL RESEARCH
ORGANIZATION

3. In this Part Determination No 27 of 1995, as amended, is referred to as the Principal Determination.
4. Under clause 3 of the Principal Determination an amount of performance based remuneration of \$42,360 is payable to Dr Malcolm McIntosh, Chief Executive Officer of the Commonwealth Scientific and Industrial Research Organization, for the 12 month assessment period 1998/99.


PART 3

PART-TIME HOLDERS OF PUBLIC OFFICE

5. In this part, Determination No 16 of 1997, as amended, is referred to as the Principal Determination.
6. The Principal Determination is further amended by:
 - (a) amending the footnote for the office of Member, Commonwealth Services Delivery Agency by deleting the words "*For a period of one year from 15 January 1998*" and replacing with "*From 15 January 1998 to 28 February 1999*".




