

# REMUNERATION TRIBUNAL

## Determination Number 12 of 1999

### REMUNERATION AND ALLOWANCES FOR HOLDERS OF PUBLIC OFFICES

Pursuant to subsections 7(3), 7(4), 8(2)(b) and 8(3) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to Secretaries of Departments and holders of public offices, and other matters significantly related thereto, and determines as set out hereunder:

#### PART 1

##### FULL-TIME HOLDERS OF PUBLIC OFFICE

- 1.1 In this Part, Determination No 5 of 1999 as amended is referred to as the Principal Determination.
- 1.2 Part 1 of the Principal Determination is amended by:
  - (a) amending the rate per annum of salary for the Executive Director, National Standards Commission to \$104,000 with effect from 31 March 1999;
  - (b) amending the rate per annum of salary for the Director-General, Australian Security Intelligence Organisation to \$152,200 with effect from 28 July 1999; and
  - (c) inserting the following footnote for the Chief Executive Officer, Australian National Training Authority "While occupied by Ms M Scollay, the provisions of Part 2 shall apply in lieu of Part 4 from the date of her appointment".
- 1.3 Table 4.3 of the Principal Determination is amended by:
  - (a) inserting the office of Director, Australian Centre for International Agricultural Research at Level 2 with effect from 1 July 1999.

#### PART 2

##### PART-TIME HOLDERS OF PUBLIC OFFICE

- 2.1 In this part, Determination No 3 of 1999 as amended is referred to as the Principal Determination.
- 2.2 Part 1 of the Principal Determination is amended by:

- (a) inserting the following authorities:

- (b) inserting the following footnote for the ComLand Limited "Additional remuneration of \$20,000 per annum is payable to the Chair for performance of the duties of Executive Chair until 1 March 2000. Member fees to be reviewed 1 March 2000."
- (c) inserting the following footnote for the Australian Nuclear and Science Technology Organisation (ANSTO) "Members of the ANSTO Board who are members of the Audit Committee will receive an additional \$5,000 per annum with effect from 1 March 1999".
- (d) amending the rate per annum of fee for the Chair, Council of the Australian Institute of Marine Science to \$25,000 and inserting a new fee of \$12,600 per annum for Member, Council of the Australian Institute of Marine Science; and
- (e) amending the footnote for Member, Airservices Australia to increase the fee for the Safety and Environment Committee from \$3,500 to \$10,000 per annum, for the period 1 March 1999 until 30 June 2000.

2.3 Part 2 of the Principal Determination is amended by:

(a) inserting the following authority:

- (b) inserting the following footnote for the New Tax System Advisory Board “Members of the New Tax System Advisory Board shall be entitled to the rates and conditions of travelling allowance as determined from time to time for officers of the Senior Executive Service of the Australian Public Service.”
- (c) removing the entry for Member, Council of the Australian Institute of Marine Science; and
- (d) inserting a new daily fee of \$450 for the Deputy Chair of the Australian River Co. Pty Ltd from date of appointment and the following footnote “Additional remuneration of \$36,500 per annum shall be payable to Mr Anson for the performance of executive duties for the period 1 April 1999 to 31 October 1999.”

### PART 3

#### CHIEF EXECUTIVE OFFICER – AUSTRALIAN FILM FINANCE CORPORATION LIMITED

- 3.1 In this Part, Determination No 27 of 1994, as amended, is referred to as the Principal Determination.
- 3.2 The Principal Determination is further amended with effect from 13 July 1999 by inserting the following clauses:
- “(2) A level of performance based remuneration of up to 15% of the salary specified in clause 1 above shall be payable annually.
- (3) The level of performance based remuneration shall be an amount determined by the Remuneration Tribunal having regard to an assessment by the Board.”
