



## REMUNERATION TRIBUNAL

### Determination 2002/14: Remuneration and allowances for various public office holders

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where specified otherwise.

#### **PART 1**

#### **FULL-TIME HOLDERS OF PUBLIC OFFICE**

- 1.1 In this part, Determination Number 9 of 2002 (as amended) is referred to as the Principal Determination.
- 1.2 Part 1, Table 1 of the Principal Determination is amended by deleting reference to the office of the Managing Director, Australian Trade Commission (AUSTRADE).
- 1.3 Part 4, Table 4.3 of the Principal Determination is amended by deleting reference to the office of the Managing Director, Australian Trade Commission (AUSTRADE).

#### **PART 2**

#### **PART-TIME HOLDERS OF PUBLIC OFFICE**

- 2.1 In this part, Determination Number 10 of 2002 (as amended) is referred to as the Principal Determination.
- 2.2 Part 1, Table 1 of the Principal Determination is amended by deleting reference to 'Aged Care Complaints Resolution Committees'.
- 2.3 Part 1, Table 1 of the Principal Determination is amended by deleting reference to 'Australian Defence Industries (ADI Ltd)'.
- 2.4 Part 1, Table 1, of the Principal Determination is amended by deleting reference to the office of 'Australia New Zealand Food Authority' and substituting the following after the reference to the 'International Air Services Commission' with effect on and from 1 July 2002:

- 2.5 Part 1, Table 1 of the Principal Determination is amended by inserting a new footnote to the reference to the office of the 'Food Standards Australia New Zealand', which reads:

"With effect on and from 1 July 2002."

This footnote will bear the next sequential number to the preceding footnote used in Table 1. After inserting this footnote all remaining footnotes in Table 1 should be renumbered sequentially.

- 2.6 Part 2, Table 2 of the Principal Determination is amended by replacing the footnote associated with the 'Refugee Review Tribunal' with the following:

*With effect from 1 July 2002, maximum fees payable each year to part-time Members of the Refugee Review Tribunal are capped at the lesser of (a) \$115,000 or (b) Total Remuneration determined for equivalent full-time offices less the value of employer superannuation contributions. With effect from 1 July 2002, Members of the Refugee Review Tribunal receive a per diem fee for seven hours work (which may be cumulative over several days).*

- 2.7 Part 2, Table 2 of the Principal Determination is amended by replacing the footnote associated with the 'Migration Review Tribunal' with the following:

*With effect from 1 July 2002, maximum fees payable each year to part-time Members of the Migration Review Tribunal are capped at the lesser of (a) \$115,000 or (b) Total Remuneration determined for equivalent full-time offices less the value of employer superannuation contributions. Members of the Migration Review Tribunal receive a per diem fee for seven hours work (which may be cumulative over several days).*

- 2.8 Part 2, Table 2, of the Principal Determination is amended by deleting reference to the office of 'Military Superannuation and Benefits Scheme Reconsideration Advisory Committee' and substituting the following after the reference to the 'Accreditation Decisions Review Committee' with effect on and from 5 April 2002:

- 2.9 Part 2, Table 2 of the Principal Determination is amended by inserting a new footnote to the reference to the office of the 'Military Superannuation and Benefits Scheme Reconsideration Committee', which reads:

"With effect on and from 5 April 2002."

This footnote will bear the next sequential number to the preceding footnote used in Table 2. After inserting this footnote all remaining footnotes in Table 2 should be renumbered sequentially.


**COMPENSATION FOR LOSS OF OFFICE**

- 3.2 Clause 1(c) of the Principal Determination is amended by replacing the word "and" with the word "or" at the end of the clause.


