



REMUNERATION TRIBUNAL

Determination 2003/24: Remuneration and Allowances for Holders of Public Offices

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to various public office holders, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where specified otherwise.

PART 1 FULL-TIME OFFICE HOLDERS

- 1.1 In this part, Determination Number 11 of 2003 (as amended) is referred to as the Principal Determination.
- 1.2 Table 2A of the Principal Determination is amended by deleting the entry for the Solicitor-General and replacing it with the following with effect on and from 25 November 2003:

- 1.3 Part 2 of the Principal Determination is amended by insert the following after clause 2.11:
'2.12 Solicitor-General: For the period from 19 December 2002 to 30 June 2003 the Total Remuneration for the office of Solicitor-General is varied to \$390,000 in lieu of that contained in Determination 2002/23 and for the period from 1 July 2003 to 24 November 2003 the Total Remuneration is varied to \$401,400.'
- 1.4 Table 2A of the Principal Determination is amended by deleting the entry of the CEO, National Road Transport Commission and inserting the following with effect on and from 15 January 2004:

- 1.5 Table 2A of the Principal Determination is amended by changing the travel tier for the Deputy Chairperson and Commissioners, ATSI Board of Commissioners from 'Tier 1' to 'Tier 2' in Column 6, with effect on and from 1 January 2004.
- 1.6 Table 3A, Column 2 of the Principal Determination is amended by changing the name 'National Road Transport Commission' to 'National Transport Commission' with effect on and from 15 January 2004.
- 1.7 Schedule A of the Principal Determination is amended by inserting the following new clause with effect on and from 1 January 2004:

'A7. Travel allowance: The Deputy Chairperson and Commissioners who hold office as at 1 January 2004 will be entitled to travelling allowance at the Tier 1 rate (rather than the Tier 2 rate) for travel within Australia until the expiry of their current appointments as Deputy Chairperson and / or Commissioner.'

PART 2 FULL-TIME OFFICE HOLDERS

- 1.8 In this part, Determination Number 9 of 2002 (as amended) is referred to as the Principal Determination.
- 1.9 In accordance with clause 4.2 of the Principal Determination (2002/09), the Remuneration Tribunal determines that the Renewable Energy Regulator shall be paid a performance bonus (for two years) of \$18,600 for the period 1 July 2001 to 30 June 2003.

PART 3 PART-TIME OFFICE HOLDERS

- 1.10 In this part, Determination Number 3 of 2003 (as amended) is referred to as the Principal Determination.
- 1.11 Part 2, **Table 2A** of the Principal Determination is amended by deleting the entry for the Chair and Members, National Road Transport Commission and inserting the following with effect on and from 15 January 2004:

- 1.12 Part 2, **Table 2A** of the Principal Determination is amended by deleting the entry for the Small Business Consultative Committee and inserting the following with effect on and from 25 November 2003:


- 1.13 In this part, Determination Number 21 of 2002 (as amended) is referred to as the Principal Determination.
