



## REMUNERATION TRIBUNAL

### **Determination 2003/02: Remuneration and Allowances for Holders of Public Offices**

- (i) Pursuant to subsections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where specified otherwise.

#### **PART 1**

#### **FULL - TIME HOLDERS OF PUBLIC OFFICE**

- 1.1 In this part, Determination Number 23 of 2002 is referred to as the Principal Determination.
- 1.2 Part 2, Table 2A of the Principal Determination is amended by deleting the existing reference to the Examiner, Australian Crime Commission.
- 1.3 Part 2, Table 2A of the Principal Determination is amended by inserting the following after the reference to the Chairperson, Productivity Commission, which reads:

- 1.4 Part 2, Table 2A of the Principal Determination is amended by deleting reference to the Member, National Crime Authority in column 1 and associated entries in columns 2 to 6.
- 1.5 Part 2, Table 2A of the Principal Determination is amended by deleting 2.2.6 and inserting the following:  
"Mr James Bennett's Base Salary will be \$197,300 until 16 April 2003".
- 1.6 Part 2, Table 2A of the Principal Determination is amended by inserting in column 5 adjacent to:  
Director - General, Australian Security Intelligence Organisation "2.2.1"  
Director - General, Office of National Assessments "2.2.2"  
Inspector-General of Intelligence and Security "2.2.3"  
Commonwealth Ombudsman "2.2.4"
- 1.7 The amendments contained in clauses 1.2, 1.3, 1.5 and 1.6 take effect on and from 19 December 2002.

**PART 2****PART - TIME HOLDERS OF PUBLIC OFFICE**

- 1.8 In this part, Determination Number 10 of 2002 (as amended) is referred to as the Principal Determination.
- 1.9 Part 1, Table 1 of the Principal Determination is amended by deleting the existing reference to the office of Disability Standards Review Panels, National Chair and Chair (other than National Chair).
- 1.10 Part 1, Table 1 of the Principal Determination is amended by inserting the following after the reference to the Disability Services Advisory Committee (Queensland):



- 1.13 Part 1, Table 1 of the Principal Determination is amended by inserting the following after the reference to Pharmaceutical Benefits Advisory Committee:
