**Determination 2013/24:  
Remuneration and Allowances for Holders of Public Office**

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to certain holders of public office, and other matters significantly related thereto, and determines as set out below.

**PART 1 – FULL-TIME OFFICES**

- 1.1** In this part, Determination Number 10 of 2013 (as amended) is referred to as the Principal Determination.
- 1.2** Table 2A of Part 2 of the Principal Determination is amended by inserting 2.2.20 in Column 4 of the entry for "Solicitor-General".
- 1.3** Part 2 of the Principal Determination is amended by inserting Clause 2.2.20 after Clause 2.2.19 as follows "**Solicitor-General:** While Mr Justin Gleeson SC does not establish his principal place of residence in Canberra he will be paid an allowance of \$34,500 per year in lieu of any travelling allowance for travel to Canberra that might otherwise be payable."
- 1.4** Clause 1.3 takes effect on and from 1 January 2014.
- 1.5** Table 2A of Part 2 of the Principal Determination is amended by inserting the following entry after the entry for "Associate Director of Public Prosecutions":

**2.1** In this part, Determination Number 11 of 2013 (as amended) is referred to as the Principal Determination.

**2.2** The Principal Determination is amended by deleting Clause F1A-1 of the Additional Clauses to Table F1A of Schedule F.

**2.3** Table F1A of Schedule F of the Principal Determination is amended by replacing the current entry for the "Independent Expert Scientific Committee (IESC) on Coal Seam Gas and Large Coal Mining Development" with the following entry:


**2.4** Clauses 2.2 and 2.3 take effect on and from 16 November 2013.
