### **Determination 2011/05: Judicial and Related Offices – Remuneration and Allowances**

---

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the day following the day it is registered in the Federal Register of Legislative Instruments unless otherwise specified.

#### **JUDICIAL AND RELATED OFFICES**

- 1.1** Determination Number 12 of 2010 (as amended) is referred to as the Principal Determination.
- 1.2** Table 1 of the Principal Determination is amended by deleting the current table "Table 1 – Rates of Remuneration – Judicial Offices" and replacing it with the table contained in Attachment A to this determination.
- 1.3** Clause 1.2 has effect on and from 1 May 2011.
- 1.4** Clause 2.2 of the Principal Determination is amended by replacing the following wording: "A Judge who also holds any of the following part-time offices shall be provided with an additional expense allowance of \$2,026 a year" with "A Judge who also holds any of the following part-time offices shall be provided with an additional expense allowance of \$2,056 a year with effect on and from 1 May 2011".
