



REMUNERATION TRIBUNAL

Determination 2008/03: Remuneration and Allowances for Holders of Public Office

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the day following the day it is registered in the Federal Register of Legislative Instruments unless otherwise specified.

PART 1 – PART-TIME OFFICES

- 1.1** In this part, Determination Number 10 of 2007 (as amended) is referred to as the Principal Determination.
- 1.2** Table A1A of Schedule A of the Principal Determination is amended by inserting "A41" in Column 4 of the entry for the "Gene Technology Technical Advisory Committee".
- 1.3** Table A1A of Schedule A of the Principal Determination is amended by deleting the entries for the "Gene Technology Community Consultative Committee" and the "Gene Technology Ethics Committee" and replacing them with the following entry:

- 1.4** The Principal Determination is amended by including Clause A41 in the Additional Clauses to Table A1A as follows "**A41. Gene Technology Committees:** an Expert Adviser appointed to either the Gene Technology Technical Advisory Committee or the Gene Technology Ethics and Community

Consultative Committee will receive \$572 per day and is entitled to Tier 1 Travel.

1.5 Clauses 1.2 to 1.4 have effect on and from 1 January 2008.

1.6 Table A1A of Schedule A of the Principal Determination is amended by inserting the following entry after the entry for "Reserve Bank of Australia":

2.2 Table 2A of Part 2 of the Principal Determination is amended by inserting the following entry after the entry for "Chairperson, Productivity Commission":
