



## REMUNERATION TRIBUNAL

### **Determination 2004/17: Judicial and related offices – remuneration and allowances**

- (i) Pursuant to subsections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where specified otherwise.

#### **JUDICIAL AND RELATED OFFICES**

- 1.1 Determination Number 14 of 2004 is referred to as the Principal Determination.
- 1.2 The Principal Determination is amended by deleting Tables 1, 2 and 3 and inserting the following tables:

(4). In addition to fees specified in Table 2, a part-time member shall be paid a cancellation fee equivalent to 50% of one day's fee for the cancellation of all work on a day with fewer than 5 working days' notice.

(5). An additional annual payment of ten times the daily fee applies.




(6). A person appointed to this office on a full-time basis before 1 October 1999 shall receive an additional annual payment of \$5,750 a year.
