# **Determination 2004/08:**

### Remuneration and Allowances for Holders of Public Offices

- Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to various public office holders, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the date of signature except where specified otherwise.

## PART 1 FULL-TIME OFFICE HOLDERS

- In this part, Determination Number 11 of 2003 (as amended) is referred to as the Principal Determination.
- Part 2, <u>Table 2A</u> of the Principal Determination is amended by deleting the existing entry of 'Member, Migration Review Tribunal' and replacing it with the following entry, with effect on and from 25 March 2004:

Part 2, <u>Table 2A</u> of the Principal Determination is amended by deleting the existing entry of 'Member, Refugee Review Tribunal' and replacing it with the following entry:

- Part 2 of the Principal Determination is amended by deleting sub-clause 2.2.2 and replacing it with the following:
  - **"2.2.2 Refugee Review Tribunal:** Where a person held an appointment as a Full-time Member of the Refugee Review Tribunal on 17 April 2004, that person will be eligible for a personal loading of \$3,990 per annum while continuing to hold an appointment (including re-appointment) as a Member. The loading does not count towards superannuation salary."
- Part 2, <u>Table 2A</u> of the Principal Determination is amended by deleting the entries of 'Deputy President, Repatriation Commission' and 'Commissioner, Repatriation Commission'.
- Part 2, **Table 2A** of the Principal Determination is amended by inserting '2.6.1' in column 5 at the entry of Chair, Australian Prudential Regulation Authority (APRA).
- Part 2 of the Principal Determination is amended by inserting a new sub-clause 2.6.1 as follows:
  - "2.6.1 APRA: Notwithstanding the above provisions, the salary for superannuation purposes of Dr J Laker will be \$393,078 from 16 April 2004, while he occupies the office of Chair, Australian Prudential Regulation Authority."

### PART 2 FULL-TIME OFFICE HOLDERS

- In this part, Determination Number 9 of 2002 (as amended) is referred to as the Principal Determination.
- Table 1 and Table 4.3 of the Principal Determination are amended by deleting the entries, including footnotes, for the offices of 'Managing Director, Australian Broadcasting Corporation' and 'Managing Director, Special Broadcasting Service'.

- In this part, Determination Number 3 of 2003 (as amended) is referred to as the Principal Determination.
- Part 2, **Table 2A** of the Principal Determination is amended by deleting the existing entry for the 'Migration Review Tribunal' and replacing it with the following entry, with effect on and from 25 March 2004:

- Part 2, **Table 2A** of the Principal Determination is amended by deleting the name of the 'Vocational Registration Eligibility Committee' and substituting 'General Practice Recognition Eligibility Committee'.
- Part 2, **Table 2A** of the Principal Determination is amended by deleting the name of the 'Vocational Registration Appeal Committee' and substituting 'General Practice Recognition Appeal Committee'.

- Part 4 of the Principal Determination is amended by deleting the names of the 1.17 following committees:
  - Therapeutic Device Evaluation Committee Advisory Panel on Biomaterials
