

## Determination 2011/17: Remuneration and Allowances for Holders of Public Office

- (i) Pursuant to subsections 7(3) and 7(4) of the *Remuneration Tribunal Act 1973*, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to members of parliament and holders of public office, and other matters significantly related thereto, and determines as set out below.
- (ii) This Determination takes effect on and from the day following the day it is registered in the Federal Register of Legislative Instruments unless otherwise specified.

## PART 1 – FULL-TIME OFFICES

- **1.1** In this part, Determination Number 8 of 2011 (as amended) is referred to as the Principal Determination.
